**Notice of Race**

**ORGANISING AUTHORITY**

- 1.1 Tognazzi Marine Village ASD in collaboration with Circolo Canottieri Aniene ASD and the Classe Kitesurfing Italia on FIV delegation.

**RULES**

2.1 The event will be governed by the rules as defined in the Racing Rules of Sailing.

- Rules as defined from the RRS W.S.
- Appendix F of RRS W.S.
- FIV Normative for sports activities organized in Italy that should be considered "Rule" from FIV Prescription
- Notice of Race, the sailing Instructions and successive Official Communications that will be exposed on the official notice board. In case of contrast between Notice of Race and Sailing Instructions, the Sailing instructions and successive communications will prevail. (modification RRS 63.7);
- Class Rules
- In case of conflict between Italian language and English language, English will prevail.

2.2 Rule 61.1 (a) of the Sailing Instructions is amended by adding the following paragraph: "Immediately after arrival, the boat shall inform the Race Committee about the intention and identity of the competitor who intends to protest".

2.3 The first sentence of the RRS 40 is deleted and replaced by: "Every competitor shall always wear when in the water a personal floatation device, except for a short time while he is changing or arranging personal clothing or equipment. Dry suits are not personal floating devices "

**ADVERTISING**

3.1 Boats maybe required to advertising chosen and supplied by the organizing authority. World Sailing Regulation 20 'Advertising Code' shall apply. Italian Competitors that show advertising shall present the FIV license for the current year.

**ELIGIBILITY**

- 4.1 The regatta is open to all athletes of the KITEFOIL class who are at least 11 years old, **with a limit of 100 competitors**, ascertained to have completed the registration.
- 4.2 An entry is considered completed when the registration form has been completed in its entirety and sent on line ([www.tognazzimv.it](http://www.tognazzimv.it)) and the payment has been made.
- 4.3 Italian competitor shall be in compliance with the CKI Class and Italian Sailing Federation including the medical prescription according to the normative.
- 4.4 Each participating boat shall be insured with valid third party liability insurance with a minimum cover of Euros 1,500,000 per event or equivalent, and a FIV licence for competitors who expose the advertisement.
- 4.5 In case of failure to submit a copy of the third party liability insurance certificate the competitor will not be allowed to participate to the regatta and the registration fee already paid will not be refunded.
- 4.6 The competitors shall deliver the entry form signed, in the case of minors, by the parent (or legal guardian) or by whom, during the event, assumes the responsibility of letting it descend into the water which will consequently assume the role of support person.
- 4.7 Each competitor that is of minor age must be associated with an accredited boat where there is a support person who assumes the responsibility of getting him / her down in the water, of assisting him / her in the phases of approaching the race course, of intervening in case of need before, during and after the performance of the races, ensuring his return to shore in safe conditions.
- 4.8 **Foreign athletes** may also register, provided they comply with the requirements of their National Authority recognized by World Sailing. and in compliance with the registration to the Class and with third party liability insurance coverage whose certificate must be exhibited in the original form and translated into English.

**ENTRY**

- 5.1 Registration must be made on the website of the Club [www.tognazzimv.it](http://www.tognazzimv.it) in the regatta registration section. The registration fee must be made by paying **the € 100.00 (one hundred / 00)** fee via bank transfer from **the 4<sup>th</sup> to the of March 31<sup>th</sup>, 2019**

5.3 Registrations and / or late payments, if accepted, will have an additional cost of € 50.00 (fifty / 00).

5.4 The Organizing Body reserves its right to extend the maximum number of participants.

In the event the regatta is not disputed due to extenuating circumstances or major force, the registration fee will not be refunded

#### LOCATION AND SCHEDULE

6.1 The regatta will be held in the area in front of the Roman coast

At the end of each racing day a pasta party will be offered to all participants.

6.3 If on the 6<sup>th</sup> the planned race has been completed and on 7<sup>th</sup> of April there are the weather conditions, a second race may be made, no request of regress will be accepted.

6.4 For the purposes of the composition of the scoring table of the record, only the best time of each competitor will be considered.

6.5 The warning signal of Sunday April 7<sup>th</sup> may be modified by notice on the notice board before 7.00 pm of the previous day.

No start signals can be given after 5.00 pm on 7<sup>th</sup> April 2019.

#### MEASUREMENTS

7.1 Only Hydrofoil boards will be allowed, while both Pump and Foil kites can be used.

#### SAILING INSTRUCTIONS

8.1 The Sailing Instructions will be available to participants from the official opening of the Race office scheduled for 2.30 pm on the 5<sup>th</sup> of April 2019.

#### COURSES

9.1 The route will be 42.195 KM long, starting from the Villaggio Tognazzi toward south with a mark in front of Torvaianica, a gate in front of the Villaggio Tognazzi, followed by another gate at Nauticlub Castelfusano, a gate at the Ostia Pier, a mark in front of the Port of Rome and back to the Villaggio Tognazzi.

9.2 The Organizing Body reserves at its sole discretion the right to modify and / or reduce the route.

#### SCORING

10.1 The scoring of the regatta will be in accordance to the minimum points, App. A of the RRS W.S.. The Ranking will be based on the general arrival order of the completed races.

#### SAFETY OF THE COMPETITORS

11.1 It is mandatory for all competitors to wear the following safety equipment:

- Personal flotation device (impact vest)
- Helmet with minimum standard EN 1385 or EN 1077 or equivalent with a minimum of 300 square centimetres of external surface and of a high visibility colour.
- GPS device
- cell phone with waterproof case
- Leash between athlete and kite

These obligations can't be object of protest between competitors

#### COACHES AND SUPPORT BOATS

12.1 All support people must register filling in the accreditation papers that can be found at the Race Office declaring :

- the characteristics of their assistance boat;
- the acceptance of the "rules for coaches and support boats" described in the Sailing Instructions, and must a portable VHF device with channels 16 and 72, the absence of the VHF device is reason for the rejection of the registration of the support boat.
- the names of the minor participants accompanied.

12.2 The accredited Supporting Persons will be subject to the technical and disciplinary guidelines of the Race committee and of the Jury which, in the event of an infraction, may act according to RRS 64.4.

12.3 In any case, the Organizing Committee reserves the right to revoke, at its sole discretion, the accreditation to the boats whose support staff does not have a working radio device and / or has not adapted to requests for support and assistance during the course of the regattas.

#### AWARDS

13.1 Awards to the first 3 classified OPEN male, OPEN female, Hydrofoil PUMP male and Hydrofoil PUMP female. The awards of the single categories will be assigned extrapolating the results from the single results of the general ranking.

13.2 **The winners will receive a 5.000,00 (five thousand) reimbursement of expenses in accordance to the procedure indicated in the sailing instructions.**

13.3 Other awards at the discretion of the Organizing Body.

## RECORD KITE FOIL MARATHON CITY OF ROME 2019

14.1 The record will be assigned to the participant that will have completed the course in the least amount of time between the disputed races.

## DISCLAIMER OF LIABILITY

15.1 Competitors participate to the event entirely at their own and exclusive risk according toRRS4 - Decision to Race, the competitors and the support people are solely responsible for the decision of taking part to or completing the race. The Organizers decline any and all responsibility for damages that may be suffered by people and / or things, both on land and in water, as a result of their participation in the regatta referred to in this Notice of Race. Competitors and the support people decide on the basis of their skills, wind force, sea conditions, weather forecasts and anything else that must be expected by a good sailor, if to go out at sea and participate to the regatta, to continue it or to renounce it.

## RIGHT TO USE NAME AND LIKENESS

16.1 The competitors grant the Organizer the right and permission to publish and / or transmit, through any media, any photograph or video footage of people or boats during the event, including, but not limited to, television commercials and anything that may be used for editorial purposes and for printed information
